They want to reinstate this area into the licensed footprint which is shown on a plan accompanying the application. The variation of conditions is sought to remove condition (d) of the On Licence to bring the licence in line with the practice note issued by the DLC on 29/09/2023 and to reinstate the sales of alcohol on Easter Sunday on the off licence.
